
Facebook's Democrat Oculus VR Head Arrested For Attempted Pedo Sex Abuse On Young Girl

Oculus engineering leader arrested near Seattle, charged with soliciting sex from cop posing as 15-year-old girl

<u>Dov Katz</u>, head of the computer vision and machine learning group at Facebook-owned Oculus, has been charged in King County for attempted commercial sexual abuse of a minor. The 38-year-old tech exec allegedly attempted to contact what he believed to be was a 15-year-old girl for sex.

The fictitious 15-year-old was actually an undercover police officer with the Tukwila Police Department, a city just south of Seattle.

The news was <u>first reported by KING 5</u>, which said that Katz was arrested by Tukwila Police on Wednesday. Katz is to be arraigned on January 5th, and bail was set at \$125,000. An Israeli citizen who resides in California, Katz is forbidden to have contact with any minors, except in the presence of a responsible adult, according to charging documents.

Katz allegedly responded to an online advertisement that offered sex in exchange for money, an ad which was posted by undercover police officer posing as a 15-year-old girl. Katz allegedly arranged a

meeting at the Embassy Suites in Tukwila, offering to pay \$350 to have sex without a condom. When Katz arrived at the hotel with \$600 in cash, he was arrested by police.

Upon his arrest, Katz told the officer that he was there to rescue the girl, and should have first called police, according to charging documents.

We've reached out to Facebook representatives for comment, and we'll update this post if we learn more. Facebook <u>purchased</u> Oculus — one of the leaders in virtual reality technology — for about \$2 billion in cash and stock in 2014. Oculus operates a large engineering office in Seattle. Katz was profiled in a <u>Times of Israel story</u> in 2014 for the role he played in helping to develop the Oculus Rift headset.

Here's how the charging documents read:

On 12/21/16 Officer Sudel was working in an undercover capacity with the Tukwila Anti-Crime Team at the Embassy Suites Hotel at 15920 West Valley Hwy doing a Buyer Beware operation, which involves Officer Sudel posing as an escort on Backpage soliciting patrons for sex. Tac Team Detectives place an ad on Backpage and then wait for potential "Johns" to call Officer Sudel.

At 1748 hours' telephone number 650-847-7549 now known as Katz, Dov contacted Officer Sudel stating "hey Santa" Officer Sudel responded "loi hi u! Wat u lookin for tonite?" Katz stated "Someone to cuddle with until tomorrow". After brief texting, back and forth Officer Sudel provided her fees and texted what he was looking for. Katz texted he wanted girlfriend experience and to stay overnight. Katz then texted if Officer Sudel wanted to come to him and she texted that she did not have a license, but she was staying at the Embassy Suites.

Katz stated that he could come to her and then texted "you have a lot of condoms?" Officer Sudel texted "oh yes babe". Katz then texted "how many times do you think you'll make me cum?".

The two of them continue to text each other with Katz stating that he would be there about 2100 hours. Katz also text for a photo which was sent to Katz. At 1843 hours Katz texted "how old are you anyways?" Officer Sudel texted "19 u?". Katz replied "30". Officer Sudel then replied "K younger girls ok with u?". Katz replied "Yes. More energy to keep up". At 1852 hours Officer Sudel texted "Can I be honest with u? I'm new to all this and a little younger then my ad says but I promise u won't be disappointed". Katz then replied "How much younger?" Officer Sudel replied "15..!'m sending my pic" "jus plz don't say anything ok?". Katz replied "sure". While the two of them were texting each other I uploaded an undercover pic of Officer Sudel to Katz and he replied "you're cute!" "And do you have another pic?"

The conversation continues with Katz wanting Officer Sudel to come to him, however Officer Sudel continued to tell Katz that she does not feel comfortable going to him with Katz finally stating that "ok I can come to you".

At 1926 hours Katz texted "do you have condoms? How many?". Officer Sudel replied "I have 5" Katz then replied "can you getr more? We will need more for sure". Officer Sudel replied "Lol can u bring sum?" Katz then replied "not sure. Worst case we can go without? Or can you get some?". Officer Sudel replied "ok I will try to call my girlfriend to bring sum". Katz replied "Alright" "let me Know" "or are you cool without?", Officer Sudel then replied "Ughhhh \$\$\$\$" and Katz replied "lol so get us condoms!" Officer Sudel replied "Yeah I will". Katz replied "Cool how many can you get?" Officer Sudel replied "dude...Ur messing with me... I can tell...I told u id get sum" Katz replied "haha just want to make sure we have enough we will have like 12 hours to play".

The two of them began to text each an hour later with Katz asking Officer Sudel if she was ready and that he would be there at or about 2115 hours. At approximately 2117 hours Katz stated that he had arrived. After giving Katz directions to the room Katz arrived in front of the room and the arrest team took Katz into custody without incident.

Search incident to arrest, \$600.00 was recovered from Katz along with his cell phone. When I arrived in the room I identified myself and told Katz that he was under arrest for Commercial sexual abuse of a minor. Immediately Katz stated that he was there to rescue her and call the police. I told Katz he should've called the police first. During the booking process Officer's asked Katz his phone number and he replied 650-847-7549, which was the same number he was texting with Officer Sudel. Upon looking at Katz's phone it appeared that he had it on airplane mode and when I sent a text the phone would go from dark screen to the sign on screen.
